ORGANIZATIONAL MEETING OF NEW BOARD**

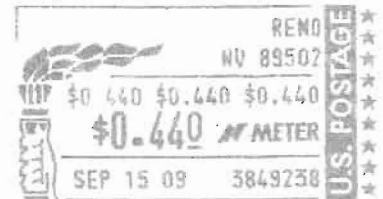
