Old Business

HBO Settlement Update – Owners received checks in the amount of \$1,000 each from the settlement. Owners with delinquencies received credits to their accounts and the remaining balances were sent to them via check.

Building of a Notice Board for the Front Entry - design will follow once the entry design is complete.

Update of Entrance Design

- Architect Selection/Proposal for Work an email version of the final design for the gates at the front entry was sent by Steve Miles to Rita's phone. The design was a composite of #4 and #3 designs with addition of the initial.
- Discussion included the design factors, whether or not the strips inside the entry were to be changed, the fact that the landscape can or cannot be established without the gate

implementation completed. The changes have been discussed at each meeting. Alex Bullentini suggested that the ARC choose the design. Jim Manly stated that \$45,000 had been set aside for enhancement of the front entry. Tom Duncan questioned if the bark, trimming and shape of the shrubs are part of the landscape contract. Russell Squelch stated that Tom Duncan's crews do great work and that a proposal should be requested from them for maintenance of the entry.
